I DO AGREE BY SIGNING THIS LICENSE APPLICATION FORM THAT I WILL ABIDE BY ALL THE RULES AND REGULATIONS SET FORTH BY EPHRATA RACEWAY PARK, INCLUDING BUT NOT LIMITED TO THE FOLLOWING:

1. I am an independent contractor assuming all responsibility for money received as a result of my activities including but not limited to: income tax, FICA, Workmen's Compensation, and withholding taxes. I am not an employee or agent of Ephrata Raceway Park.
2. I have or will have familiarized myself with all Ephrata Raceway Park rules and regulations including car specifications, safety rules, and specifically agree to abide by all the Ephrata Raceway Park rules.
3. I agree that I will be the sole spokesperson for myself, the car owner, and the crew in all matters pertaining to compliance with the rules and regulations and I agree and understand that I am responsible for my crew.
4. I agree and understand that by submitting my race car for various technical and safety inspections, I certify that the race car meets all rules and regulations for participation in Ephrata Raceway Park events and that the burden of proof will rest upon me to show that I am in compliance with all Ephrata Raceway Park rules and regulations.
5. I agree to appropriately use all required stickers, decals, patches and I understand that failure to do so will result in loss of points and forfeiture of all money and awards for the event.
6. I agree that all decisions of Ephrata Raceway Park race officials, or track officials, regarding interpretation and application of Ephrata Raceway Park rules and the scoring of positions, shall be non-litigable. I further covenant and agree that I will not initiate any type of legal action against Ephrata Raceway Park to challenge such decisions, to seek monetary damages, to seek injunctive relief or to seek any other kind of legal remedy. I understand that should I pursue any legal action, which violates this provision, then I expressly agree to reimburse Ephrata Raceway Park and promoters for all of its attorney fees and costs in defending against such legal action.
7. I understand that that there is no express or implied warranty of safety resulting from publication or compliance with the rules of the Ephrata Raceway Park, and that they are intended as a guide for the conduct of the sport and are in no way a guarantee against injury or death to participants, spectators or others.
8. In the event the undersigned breaches this agreement, he shall be liable for actual and liquidated damages sustained by Ephrata Raceway Park.
9. As owner of a registered car, I certify I have marketable title to the competition vehicle, free and clear from liens and will deliver title to said vehicle or any part thereof if claimed pursuant to the rules.
10. I also agree to release all advertising and promotional rights to my name, car and likeness to Ephrata Raceway Park and sponsors.
11. Any controversy or claim arising out of or relating to this agreement, including any alleged breach, shall be settled in accordance with the rules of Ephrata Raceway Park. The undersigned agrees to accept the decision as final without appeal.
